## Insurance coverage:

Acceptance of cancellation costs for charter customers

## Scope of coverage (excerpts) - Highlights:

- You or a traveling companion becomes ill or injured, or develops a medical condition disabling enough to make you cancel your trip. Included is the diagnosis of an epidemic or pandemic disease such as COVID-19, as well as pregnancy problems.
- A family member who is not traveling with you becomes ill or injured, or his medical condition deteriorates. Included is the diagnosis of an epidemic or pandemic disease such as COVID-19, as well as pregnancy problems.
- You, a traveling companion, family member, or your assistance dog dies on or after your policy's Coverage Effective Date and before your trip.
- You or a traveling companion is quarantined before your trip due to having been exposed to: a contagious disease other than an epidemic or pandemic or an epidemic or pandemic (such as COVID-19).
- You or a traveling companion is involved in a traffic accident on the departure date.
- Your travel carrier cannot get you to your original itinerary's destination for at least 24 consecutive hours from the originally scheduled arrival time due to, for example, natural disaster or severe weather.
- You or a traveling companion is terminated or laid off by a current employer after your policy's purchase date.

- The costs of an external skipper, even if those were not included in the travel price, are covered up to EUR 1,000.

## Proof in case of COVID-19:

PCR test or quarantine confirmation

## Proof of illness:

Medical certificate

## Scope of validity:

All destinations provided through Pitter Yachtcharter

## Insured persons:

All nationalities

## Insured sum:

15,000 EUR per booking

## Premium costs:

A service provided by Pitter Yachtcharter. No additional costs for you as a customer.

## Payment of cancellation costs:

Directly to the charter customer who, in the event of a claim, refers directly to the insurer. For USA: compensation by Pitter Yachtcharter.

## Data for the insurance contract:

Names of all charter customers (travelers), name of the skipper, travel price, travel date
